Recently, July, 2000, this website, www.projecttruth.com, received several e-mail's and other correspondences from individuals who claim to have been sexually assaulted-historically, in and/or around Cornwall, Ontario, Canada. Several of the principles mentioned in the recent correspondences state they have, in past months or years, or, have just recently provided public officials with similar information as submitted herewith. In fact, many of the forthcoming testimonial's and supporting attachments, are already in the public domain, having been submitted as supporting evidence for the original allegations (see "[The Story](#)") and being discussed in part or in whole in the Canadian Broadcasting Corporation special entitled, "Breach Of Trust" which aired April and May 1999. The recent correspondences and attachments were submitted with a request from the "senders" to include the correspondences, in their entirety, on the www.projecttruth.com website. The "Senders" state that, in light of the recent Latour judgement ([Latour Found Not Guilty](#)), combined with, (in some cases), over 30 years of enduring personal pain and suffering at the hands of pedophiles, sexual predators and sexual deviants, including the offender's "soldiers", many of the "senders" feel the flicker for possible justice appears to have now been extinguished.

Closed System All parts are rigidly connected or disconnected (alienated, ostracized) altogether. Information does not flow between parts or from outside in and inside out. Closed systems evolve from certain beliefs such as; a) people must be continually controlled to be any good; b) relationships must be regulated by force or by fear of punishment; c) there is one right way, and the person with most power has it; d) there is always someone who knows what is best for you; e) self-worth is secondary to power and performance; f) actions are subject to the moods of the boss; g) change is resisted; in closed systems communication and rules are covert, suppressed, indirect, unclear, unspecific, incongruent, growth-impeding, blaming, placating, distracting, out-of-date, inhuman, fixed, people change their needs to conform to the rules, restrictions on commenting.

Open System All parts interconnect and are interdependent. All parts are responsive and sensitive to one another. Information flows freely between the internal and external environments. Open systems evolve from certain beliefs such as; a) self-worth is primary; b) power and performance is secondary; an individual's actions represent their beliefs; c) change is welcomed and considered normal and desirable; d) communication, the system, and rules all relate to each other, they are overt, up-to-date, direct, clear, congruent, growth-producing, nurturing, full freedom to comment on anything; e) an open system can choose to be open or closed when it fits, the important word is "choice."

Jan-March. 1999 (April '99)

February 1992 : D.S. tells Church officials he was molested by Father Charles Macdonald.

09 December 1992 : D.S. reports his allegations to Cornwall Police.

28 January 1993 : D.S. is interviewed by Cornwall Police.

16 February 1993 : D.S.'s victim's statement is turned in to Cornwall Police.

02 September 1993 : The gag order brokered by Malcolm MacDonald is signed. D.S. receives \$32,000.

23 September 1993 : Constable Perry Dunlop learns of the D.S. allegations.

25 September 1993 : Dunlop talks to Richard Abell of the Children's Aid Society.

30 September 1993 : Copy of D.S.'s victim's statement is given to the Children's Aid Society.

07 October 1993 : Police Chief Claude Shaver goes to Papal Nuncio.

12 October 1993 : Perry is told he is going to be investigated by his police force.

16 October 1993 : Local media report that Malcolm MacDonald was knighted into the Order

of St. John of Jerusalem.

02 November 1993 : Police Chief Claude Shaver announces his early retirement.

7
25 November 1993 : Ken Seguin, the probation officer accused by D.S. commits suicide.

06 January 1994 : D.S.'s victim's statement is leaked to media.

11 January 1994: Ottawa Police are called in to investigate Cornwall Police handling of the D.S. allegations.

15 January 1994: Jacques Leduc and Bishop Eugene Larocque deny the monetary settlement contains a gag

order.

24 January 1994: Bishop Larocque admits the D.S. payoff contained a gag order.

February 1994: Ontario Provincial Police investigates allegations against Father Charles MacDonald and

Later that year announces it has no grounds to lay charges against him.

01 March 1994: Children's Aid Society concludes that Father Charles MacDonald molested D.S.

14 May 1994: Dunlop is charged with discreditable conduct under the *Police Services Act*.

23 September 1994: A Board of Inquiry is held in Ottawa.

31 January 1995: All charges against Dunlop are stayed. The Police Complaints Commission appeals the

decision.

07 February 1995: Malcolm MacDonald is charged with obstruction of justice.

12 October 1995: Malcolm MacDonald pleads guilty and receives an absolute discharge.

07 December 1995: Divisional Court dismisses the Police Complaint's Commission's appeal with costs and

upholds the Board of inquiry decision to stay charges against Dunlop.

11 March 1996: Father Charles MacDonald is charged with seven counts of indecent assault against

three former altar boys.

13 November 1996: "Richard" signs an affidavit outlining his first-hand account of a pedophile-ring.

08 April 1997: Perry Dunlop deposits documents with the Attorney General and the office of the

Solicitor General. Ontario Civilian Commission on Policing Services.

August 1997: Ontario Provincial Police launch "Project Truth."

27 January 1998: Father Charles MacDonald is charged with six more counts of indecent assault and two of

gross indecency.

11 June 1998: Diocese of Alexandria-Cornwall attempts to gag Perry Dunlop and his family.

22 June 1998: Jacques Leduc, former legal counsel for the Archdiocese of Alexandria-Cornwall, is

charged with twelve counts of sexual assault.

09 July 1998: Project Truth charges seven men with sexual offences which date back thirty years.

Superintendent Fougere says Project Truth is scheduled to wrap up in September.

31 July 1998: Perry Dunlop gives Project Truth the missing documents.

18 September 1998: Gary Guzzo (member of Ontario's Progressive Conservative Provincial Government)

sends first letter to Premier Mike Harris.

05 January 1999: A 54-year old male is charged with 16 counts of sexual assault against males and

females between 1986 and 1998.

23 February 1999: Gary Guzzo writes second letter to Premier Mike Harris.

11 March 1999: Malcolm MacDonald is charged with three counts of sexual assault. One other man is

charged.

Jacques Leduc has four more charges added to the previous 12.

Detective Inspector Grassman says he thinks the investigation will wrap up in the summer.

21 March 1999: Gary Guzzo's letters to Premier Mike Harris are in the public domain.

03 April 1999: "*Ottawa Sun*" reports that a couple claim their son was molested by one of Dunlop's prime suspects.

A List of people who have been charged:

Here is a list of people who have been charged, convicted, died or have committed suicide since 1993.

1) Father Charles MacDonald- Catholic Priest named in original complaint in December 1992 by D.S.

2) Milton MacDonald- Former Reeve of Lancaster Township and father of the senior Crown Attorney of Stormont, Dundas and Glengarry, *charged, convicted and jailed* for multiple counts of sexual assault of children.

3) Ken Seguin- Probation Officer named with Father Charles MacDonald in original December 1992 complaint by D.S. *Committed suicide in November 1994.*

4) Marcel Lalonde- School Teacher with the Catholic School Board. *Charged* with multiple counts of sexual assault of children including multiple victims. Trial is postponed until September 2000.

5) Father Kenneth Martin- Catholic Priest *charged* with sexual assault on a minor.

6) Earl Landry Jr.- Son of a former Cornwall Police Chief, Earl Landry, worked as a park leader for the City of Cornwall. *Charged and convicted, sentenced to 5 years in jail*, December 1999.

7) Doctor Arthur Peachey- Coroner for the City of Cornwall for twenty years and team doctor for the Cornwall Royals Major Junior Hockey Team. *Charged* with sexual assault on a minor. Was waiting a trial date to be announced in December 1999-January 2000. *Passed away* in his home in December 1999. (a post-mortem (autopsy report) has not yet be made public (01-01-2000).

8) Jacques Leduc- Lawyer in the City of Cornwall and a past president of the Local Canadian Bar Association as well as former Head of the Catholic School Board, former Diocesan Lawyer who drew-up the \$32,000. (D.S. original complainant)deal with "gag-order." *Charged* with multiple counts of sexual assault including multiple victims. Preliminary hearings concluded in December 1999 that Jacques Leduc will stand trial.

9) Father Leonel Carriere- Catholic Priest *charged.*

10) Nelson Barque- Former Probation Officer for the City of Cornwall who worked and socialized with Ken Seguin (#3 above); Nelson Barque was *charged, convicted and jailed* for sexual assaults on a minor. He was being investigated for further allegations against him and he *committed suicide* on July 28, 1998.

11) Roch Landry- Business Owner in Cornwall, Ontario *charged* with assault on a minor.

12) Father Paul Lapierre- Catholic Priest *charged*.

13) Harvey Latour- Former business owner in Cornwall, Ontario and close friends of Malcolm MacDonald and other's named as alleged offenders. *Charged* with sexual assault.

14) George Lawrence- Former business owner in Cornwall, Ontario, and *charged* with sexual assault.

15) Jean-Luc Leblanc- Bus driver for the Catholic School Board and former employee of a local training institute. *Charged* with multiple counts of child sexual assault.

16) Thomas Cronin- Speech Therapist *charged* with sexual assault of children.

17) Richard Hickerson- Retired from a senior position at Canada Manpower *was being investigated*. He *committed suicide* on June 19, 1998.

18) Malcolm MacDonald- Former Federal Crown Attorney and retired lawyer who also received the Highest Order in the Catholic Church that could be received by a layman. Malcolm MacDonald was charged with sexual assault of young boys. *Charged and convicted* of obstructing justice in the initial complaint by D.S. and the brokering of the \$32,000. settlement which included a non-disclosure ("gag order") clause. Later with sexual assault. *Passed away* in December 1999 while visiting Fort Lauderdale, Florida and awaiting trial.

19) Bernard Sauve- Cornwall businessman *charged* with sexual assault of minors.

20) Brother George Edmond- *Charged* by "Project Truth" and charged with sexual assault of minors.
