STATEMENT: CONSTABLE J. PARIEN

I object to and claim privilege from the use of all, any part or parts of this statement in any proceeding, whether criminal or civil and including disciplinary proceedings or in any investigation or inquiry without my consent. Subject to the above and in compliance with and only under the compulsion of your order, I submit the following in an attempt to resolve the matter informally:

This is to acknowledge your letter dated March 25, 1994.

Concerning the public complaint made by Mr. David Silmsler, I wish to point out that I was not assigned this initial case, nor was I involved in any way in this investigation as a police officer. My only involvement or knowledge of this case is either 1) through the media, or 2) after having Association members approach me seeking advice in my capacity of President of the Association.

I do not recall exactly when the first officer approached me, however I believe it to be the late fall of 1993, advising me that he was under investigation for having shown a copy of a statement given to the police department to a member of CAS. At that time, I was shown a copy or what I believe to be a copy of the statement that had been given to CAS: The member in question was requesting to know what his rights were subject to the investigation being conducted on him.

In early 1994, I was approached by a second member of the Cornwall Police Association who was also concerned about their rights and duties relating to this case.

To address the public complaint form # 1 re; specific allegations of misconduct, I have no knowledge of the letter from Mr. Bryce Geoffrey, therefore I am not in a position to comment on it. In regards to the unauthorized release, it's as stated above, I was shown a copy of Mr. Silmsler's statement to police.

I have no notes or documentation on this matter as I was never assigned the initial or any follow-up investigation on this case. This concludes my limited knowledge of this case. I trust this complies with your order.
