QUESTIONING BY DETECTIVE SERGEANT HAVILAND:

Q. Today is Monday, March 19, 2001. The time is 10:45 p.m. We are located at the Wyckoff Police Department Detective Bureau.

Michael, my name is John Haviland. I'm a sergeant with the Bergen County Prosecutor's Office, currently assigned to the Sex Crimes and Child Abuse Unit. Seated to my right is Detective Jason Love of the Bergen

County Prosecutor's Office, and to my left is Detective Daniel Kellogg of the Wyckoff Police Department. And also in the room is Karen Sole, who's a stenographer taking your statement here.

Earlier we had stopped by St. Elizabeth's rectory and requested if you could come down to the police department to speak to us. Prior to any questioning here today, did I read you a series of questions?

- A. Yes, you did.
- Q. And do you recognize this form that I put in front of you?
- A. Yes.
- Q. At this time I'd like to mark this as S-1 for identification.

 (A Miranda rights form is marked S-1 for identification by the reporter.)
- Q. Do you recognize this form?
- A. Yes, I do.
- Q. And is that, in fact, your signature?
- A. It is.
- Q. And did I read each one of those questions to you?
- A. You did.
- Q. And did you also read each one to yourself?
- A. I did.

Q. Are you willing to provide me with statement at this time?A. Yes, I am.Q. Can you raise your right hand?

WITNESS SWORN:

- A. I do.
- Q. For the record, can you please state your full name, spelling your last name?
 - A. Michael Charles Fugee, F-u-g-e-e.
 - Q. And your home address?
 - A. 700 Wyckoff Avenue, Wyckoff, New Jersey 07481.
 - Q. And what is that?
 - A. That is the rectory of the Church of St. Elizabeth.
 - Q. What is your phone number there?
 - Α.
 - Q. Your date of birth?
 - A. February 1, 1961.
 - Q. And your Social Security number?
 - A.
 - Q. And what is your present position at St. Elizabeth's?
 - A. Parochial Vicar.

- Q. Is that a priest?
- A. Yeah, assistant pastor, priest.
- Q. And how many years have you been a priest?
- A. Şeven.
- Q. How many parishes have you been associated with?
- A. Two, including this one.
- Q. What's the other one?
- A. St. Rose of Lima in Short Hills.
- Q. And when did you come to St. Elizabeth's?
- A. December 7, 1997.
- Q. Okay. How long have you known the family?
- A. Since I met the family at church my first Sunday in the parish, so three and a half years.
- Q. Okay. And during the course of that time, have you assisted with her divorce and other issues?
- A. She was already separated when I came into the parish and was subsequently divorced during my time knowing her, yes. It became final after I met her. I did not assist her with that.
 - Q. Okay.
 - A. I did not walk her through the separation in any way.

- Q. Would you consider yourself a friend of the family? A. Yes. Q. And have you been to their home? A. hhave. On a number of occasions? A. Yes, many. Q. Did there come a point in time where you had a problem with her son, A. Yes. Q. Okay. When was this, approximately? A. Approximately six months ago. Q. Okay. Which would be? A. August of 2000.
- Q. And where were you?
- A. In Williamsburg, Virginia.
- Q. And who was there?
- A. Myself and and his mother.
- Q. And where exactly were you?
- A. In Williamsburg, Virginia, a hotel.

- A. There was no marked reaction. I mean, we stopped wrestling, but there was no marked nothing no marked departure as there was in Williamsburg at all.
 - Q. Okay. Based on what you just told me about these two incidents, in our mind, would these acts be considered crimes or illegal?
 - A. Yes, of course, violation.
 - Q. And you know you've done something wrong?
 - A. Yes, I know I've done something wrong.
 - Q. Okay. Have you told anybody about these acts that you've done

against ?

- A. No, I have not.
- Q. And are there any other individuals or minors out there that you've done something like this to?
 - A. No, there is not, none, no.
- Q. When did it come to your attention that this matter was going to be public or be investigated?
 - A. Last -- a week ago today. Last Tuesday.

- Q.. And how did it come to your attention?
- A. Through a phone call from Monsignor Finnerty, who is the Vicar for Clergy of the Archdiocese of Newark.
 - Q. At any time, did you tell not to tell anyone about this?
 - A. None, absolutely.
 - Q. Have you ever threatened him?
 - A. No.
 - Q. Did you ever have his mother threaten him?
- A. No. Actually, I urged his mother to find out what it was that was wrong.
- Q. But in your mind, you did know why he was acting like this toward you?
 - A. Yes.

- Q. Did they witness the incident?
- A. I don't think they saw anything happen.
- Q. They just assumed it was a wrestling match?
- A. Yes.

DETECTIVE KELLOGG: That's it.

QUESTIONING BY DETECTIVE SERGEANT HAVILAND:

- Q. Michael, have you been treated fairly by the members of the Prosecutor's Office and Wyckoff Police Department?
 - A. Yes, definitely.
- Q. Have we forced you or threatened you in any way here to provide us with this information?
 - A. No, definitely not.
 - Q. And has everything you told us been the truth?
 - A. Yes, it has been the truth.
