Priest charged in sex offences

Police ask victims to come forward

Father John McCann, a Roman Catholic priest, was arrested and charged in New Westminster provincial court Thursday with six counts relating to sexual offences involving females under the age of 16. Police are asking anyone having information to these incidents or similar incidents to contact them. The sexual assault charges include sexual intercourse, indecent assault and gross indecency all with a females under 14 years of age.

The alleged offences took place while Father McCann was serving as a priest at St. Peter's Church on Royal Avenue from 1975 to 1979 and at St. Augustine's Church

in Vancouver from 1972 to 1973. The complaints involve more than one female, police said, but refused to say how many. The arrest resulted after a six-month investigation sparked by complaints to the police department. Police say Father McCann was working with young people at the parish. He was in charge of St. Peter's when the alleged offences occurred. Former students say he also occasionally drove them to school in the church van. Father McCann also served as parish

St. Patrick's church, Lethbridge, Alberta from 1963 to 1970; Fort St. John, B.C. from 1981 to 1983; Edmonton, Alberta from 1984 to 1990; and Ganges, Salt Spring Island August 1990 until October 1990 at which time he was removed from

Father Mendenhall, media spokesman for the Roman Catholic Church, refused to the arrest, saying the issue Police say investigation into the allegations is continuing. Police are also asking anyone having information
