My Dear Friends & Benefactors,

Mother Theresa of Calcutta was once asked by a reporter, "Are you discouraged that you cannot help all the people on the streets of Calcutta?" She responded, "No. I just help them one at a time." That response applies equally to the ministry of **Justice for Priests and Deacons**. We strive to defend the canonical rights of clergy, religious women, and laity who contact us. We work to bring comfort and direction to them regardless of the circumstances of their case.

Since 1997 when a group of canon lawyers decided to form our organization, we have helped over 800 priests and deacons from the United States and overseas. Almost daily we receive new inquiries. Thanks to a team of over 90 canonists and civil lawyers, we have informed and supported priests and deacons so that they will know their rights under canon law and civil law when they are required to defend themselves against injustice.

In the analogy of the Good Shepherd who seeks the lost and wounded, our ministry is to seek justice for clergy, religious, or lay person who needs help:

- **We help** clergy removed from active duty and are bewildered by an avalanche of charges that beset them. Many have little support or advice from their bishops or provincials.
- **We help** those who are innocent and have to endure accusations and punishment which destroy their reputation and credibility. Usually they are presumed guilty until proven innocent. Who else corrects the damages that come from false accusations?
- **We help** some who are guilty of moral failures and indiscretions and have suffered excessive punishment from their superiors with little recourse of action. There usually is no one to argue on their behalf. *We need to correct the injustice in these cases according to the laws of our Church and our civil government.*

We personally keep in touch with almost forty priests who are incarcerated to bring them some hope and consolation. With one exception, they have received no financial support from their

bishops. In many cases, actions from their bishops have worsened their condition, made them more vulnerable, and put them in a much worse situation than is deserved. Thanks to your generosity we send them a donation several times a year.

I know that **Justice for Priests and Deacons** receives criticism from those who believe that the guilty should be punished and thrown out of the priesthood. Yes, there are those who are guilty and should no longer serve as priests and deacons. But these men also need compassion and assistance to rebuild their lives. Is that foreign to the Gospel of Jesus Christ? And who else does that in our Church today?

**Justice for Priests and Deacons** believes that innocent or guilty, our priests and deacons have a right to proper counsel and guidance at a very critical and devastating time in their lives. Some priests have ended up in the streets and in destitution because they were abandoned by their spiritual leaders. That is not right.

I come to you for assistance at this transition moment in our history. For all these years I have relied mostly upon volunteers and they do a great job for us. I do not take a salary and my expenses are kept at a minimum. But the volume of work is catching up to me. To go on any longer without a qualified office manager is not wise.

In consultation with our Business Board and Academic Board, I believe it is time for us to hire an administrative assistant who can oversee the office tasks and procedures that will best serve our ministry. This will give me more time to serve the pastoral needs of our clients spread across the country and overseas, while still fulfilling our mission to defend the canonical rights of priests, religious and laity. We cannot move in this direction unless there is a significant increase in the level of giving by our donors. We need your help, and you might also ask your friends to help.
